- Dakshinkali Municipality** invites electronic bids from eligible bidders for the construction of BASBARIPARK/DM/NCB/WORKS/2077-78/09, under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 6,67,27,453.4025/-
 - Minimum Work experience of similar size and nature: at least **1 work experience of value** NRs 7,11,75,950.296/-
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/egp.
- A complete set of Bidding Documents can be downloaded from e-Gp system www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit Rs 5000/- (Five thousands only) cash of bidding document in the revenue account as specified below and scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- Pre-bid meeting shall be held at **Meeting Hall of Dakshinkali municipality** at **2078-03-10 at 14:00**.
- Electronic bids must be submitted to the office **Dakshinkali Municipality** through PPMO's e-GP system www.bolpatra.gov.np/egp before **12:00** on 2078-03-21. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 on 2078-03-21**, at the office of Dakshinkali municipality. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **22,25,000/-** which shall be valid for 30 days beyond the validity period of the bid **2078-07-21**.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
